One shall be a young adult and one member may be a youth. All shall be members of the local charge or associate members (in other UM churches). No staff member or immediate family member of a pastor or staff member may serve on the committee. In addition, the lay leader and a lay member of the annual conference shall be members. Only one person from an immediate family residing in one same household shall serve on the committee.” (Selections from paragraph 258.2)
